**Erik Bodensten** has a PhD in history and is a Researcher at Lund University. He has specialized on Swedish eighteenth-century history and is currently studying how France, Russia, Great Britain, and Denmark tried to influence Swedish foreign policy 1719–1772. **Tilman Haug** has a PhD in history and is a postdoctoral scholar at Universität Duisburg-Essen. He is an expert on early modern diplomacy, corruption, and patronage, as well as on state formation. He currently studies early modern lotteries, speculation, and state finance. **Tryntje Helfferich** is an Associate Professor of History at the Ohio State University. She is an expert on central Europe and France during the early modern period, with a particular focus on the Reformation era (1500–1650) and the period of the Thirty Years' War (1618–1648). Her publications include *The Thirty Years War: A Documentary History* (Indianapolis: Hackett, 2009); *On the Freedom of a Christian* (Indianapolis: Hackett, 2013); *The Iron Princess: Amalia Elisabeth and the Thirty Years War* (Cambridge, MA: Harvard University Press, 2013); and *The Essential Thirty Years War* (Indianapolis: Hackett, 2015).

**Marianne Klerk** has a PhD in history and is an Associate Member of St Antony's College, University of Oxford. Her expertise includes economic, international, and military history. Currently she studies the reliance of (nascent) early modern states on external partnerships for resource mobilization with a focus on seventeenth-century Amsterdam. **Philippe Rogger** has a PhD in history and is a Researcher at Universität Bern. He is an expert on pensions and transnational patronage in the sixteenth-century Swiss confederacy. Currently he studies Swiss confederate military entrepreneurship in the early modern period.
